Uttarakhand Irrigation Department wishes to find long term solution for slope stabilization work for Harinagar I, II Distt. Nainital Uttarakhand.

The purpose of getting slope stabilization work is to save Harinagar I, II as well as adjoining area which is unstable. Due to unstable slope area is falling day by day and its intensity enhance during rain.

This is very useful for safety and security of Nainital town. The total population of Nainital town as per 2011 census is 41377 people.

Consultant will be carrying out study for the said area for its stabilization and based on the study will suggest remedial and management measures, methodology will provide engineering design and drawing and will provide all assistance for its execution within 03 months from date of agreement.

- 3- The organization / agency/ individual consultants should have an annual average turnover not less than 10 crore in last three completed financial year. (attach 03 year financial statement with proposal)
- 4- The organization / agency/ individual consultants should have provided consultancy for work, not less than Rs. 10.00 crore in slope stabilization work and based on suggestion made by him work has been accepted by the State Govt./Central Govt. and the slope which has been stabilized are still in good condition at least for the last 03 years (detail to be attached with proposal).
- 5- Details of Slope Stabilization work designed for the similar project implemented by the firm (copy of project report with detail design calculation to be annexed with proposal).
